## Paid Externships paying off

## Waiting list growing for new attorney recruitment program

In the never-ending battle to grow the staff and attorney ranks to meet client needs, LOPD launched a statewide paid externship program for new attorneys in 2024. It is showing great results.

The program allows externs to work for LOPD for a stipend in the spring, fall and summer on a full or part time basis for eight weeks. They can earn up to \$10,000 full time in Santa Fe, Las Cruces and Albuquerque. In the other offices they can earn up to \$12,000 full time. The money comes from the Public Attorney Fund that was passed by the New Mexico Legislature in 2023. Deploying it has taken a lot of work from LOPD's fiscal and admin teams.

"We want to attract dedicated public defenders from as varied of backgrounds and experiences as possible," said LOPD Training and Recruitment Dir. Liz Holmes. "We have people who want to work as public defenders but can't afford to take an unpaid externship. Now they can."

When the project was launched in 2024, LOPD placed 13 externs in five offices. Out those 13, eight have joined or will soon join the department fulltime as Limited Practitioners.

In 2025, LOPD received applicants from around the country, and 21 positions have been filled in eight offices statewide so far.

"We continue to explore different opportunities to find a diverse attorney force dedicated to public defense. This outreach is paying off and we will stay committed to finding new and innovate ways to recruit attorneys to LOPD," Holmes said. "And thank you to the managers and supervisors taking on these great externs. This is good for all of us."

I did a summer externship at the NM LOPD where I was fairly compensated and given meaningful work to do. LOPD has you work with real clients, on real cases, and they give you real work. I was not given tasks to keep me busy but instead, I was given the opportunity to help clients substantially. I learned more about being an attorney from my externship at the LOPD than any other experience. The LOPD also works to foster camaraderie at the firm, and in my experience, there was always someone around to ask for help or to back you up. If you are thinking about going into this field I would highly recommend an externship at the LOPD.

## Dinner with new friends

Chef Fernando Ruiz is using his wellearned cooking fame - he even beat Bobby Flay! - to provide career opportunities for formerly incarcerated people at his restaurant Escondido Santa Fe. And using his own background of having been incarcerated and building a new life, Ruiz is advocating for more robust re-entry programs in the state's prisons.

Chief Baur and Deputy Chief Philip Larragoite visited Ruiz at Escondido earlier this year to discuss supporting his efforts and partnering on possible community events. And, of course, to enjoy the food.

"There were legislators and community members talking about the need to help people transition out of prison and back into the community and to create job opportunities for them, The people at Escondido know it and we know it. This is truly the way to help people coming out of prison succeed," Baur said. "And the food was excellent."

### Abq renovations

Some building renovations are in store for the Albuquerque office.

In a few weeks, the Albuquerque office will begin an office reconfiguration project to make room for LOPD's growing externship program, IT, Fiscal, and HR units and some office shuffling for our Appellate unit.

Once construction and moving is completed, IT will be housed on the 17th floor. Their former space on the 8th floor will house expansions for Albuquerque trial employees.

### **De-escalation training**

A special training is scheduled for core staff aimed at empowering them with de-escalation techniques. The Southern offices will have their training next month, and ABQ and northern offices in June. The training was developed and will be led by NAPD's Social Work Training & Resources Coordinator Stephanne Thornton.

Topics to include: Recognizing signs of escalation; Notes on psychosis and escalation; Introduction to Relationship Management: Emotional Quotient; Introduction of traumasensitive work in public defense as an antidote to escalation; Active Listening; Verbal Strategies; Physical Environment; Cultural Humility; Body Language and Nonverbal Communication; Team Communication; Debriefing and Learning from Incidents.


