PROHIBITION OF REDISCLOSURE: Federal regulations (42 CFR Part 2 and 45 CFR 164.502(a)(5)(iii)) and State Laws (NMSA 197843-1-19, 32A-6A-24-2B-7 and 24-1-9.4) prohibit further disclosure of mental health or alcohol and/or drug abuse treatment information and of the results of tests for HIV/AIDS and other sexually transmitted diseases to any person or agency without securing another proper written authorization for that purpose, or as otherwise permitted by federal regulations or state laws.
